SALE OBJECTIVES: The harvest objective is to promote oak retention on the site by removing suppressed maples and thinning out red oak groves to give a crown release to existing crop trees. Single-tree selection is used to release crop trees and to limit the area in large gaps which can convert in to berry bushes. Marking removed mostly suppressed, poor- quality trees, with some prime veneer and mature sawlogs. Maple quality can vary. Red oak log quality is good with a high proportion of grade 1 logs, some veneer with most of the rest in grade 2.

Access & Terrain- The site can be reached by coming from Hwy 150th Avenue and going east on a graveled road about 500 feet to a woods road on land owned by Bill Brodacki. (See map) A road crossing over the wetland will need to be reconstructed using fill from the side of the hill. A new 24' x 14" culvert will need to be installed in the crossing to prevent flooding above the fill site. Terrain is rolling hills with several steep slopes. Soils are mostly sandy loams with some pockets of silt loam and some wet swales. The wood will need to be forwarded to a landing (See Close Up map) about 500 feet south of the SW corner of the timber sale area because there are no internal roads on the BCPL property. Forwarding distances will vary from as little as 500 feet to as much as 2,200 feet and average about ¼ mile.

OTHER SALE REQUIREMENTS AND CONDITIONS:

- The BCPL can restrict the type of equipment used on the job if conditions or damage warrant.
- BMP's (see Field Manual PUB-FR-093-2010) are mandatory for this sale.
- Notify the BCPL (715-277-3366) before you start the job.
- Sawlog volume estimates are from a 100% tally. Hwd pulp is estimated at 2.5 tons/cd.

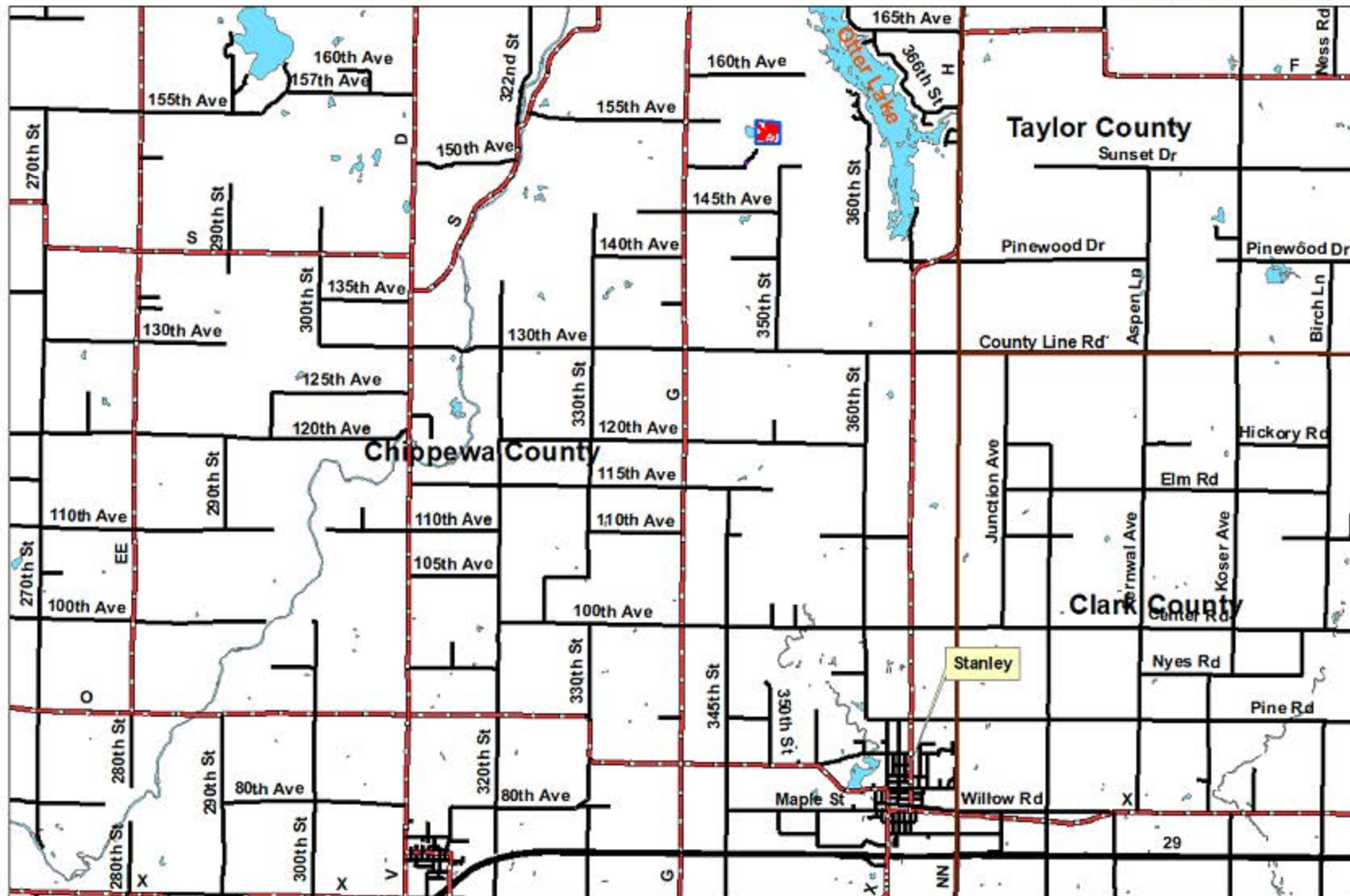

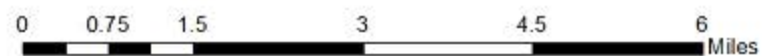

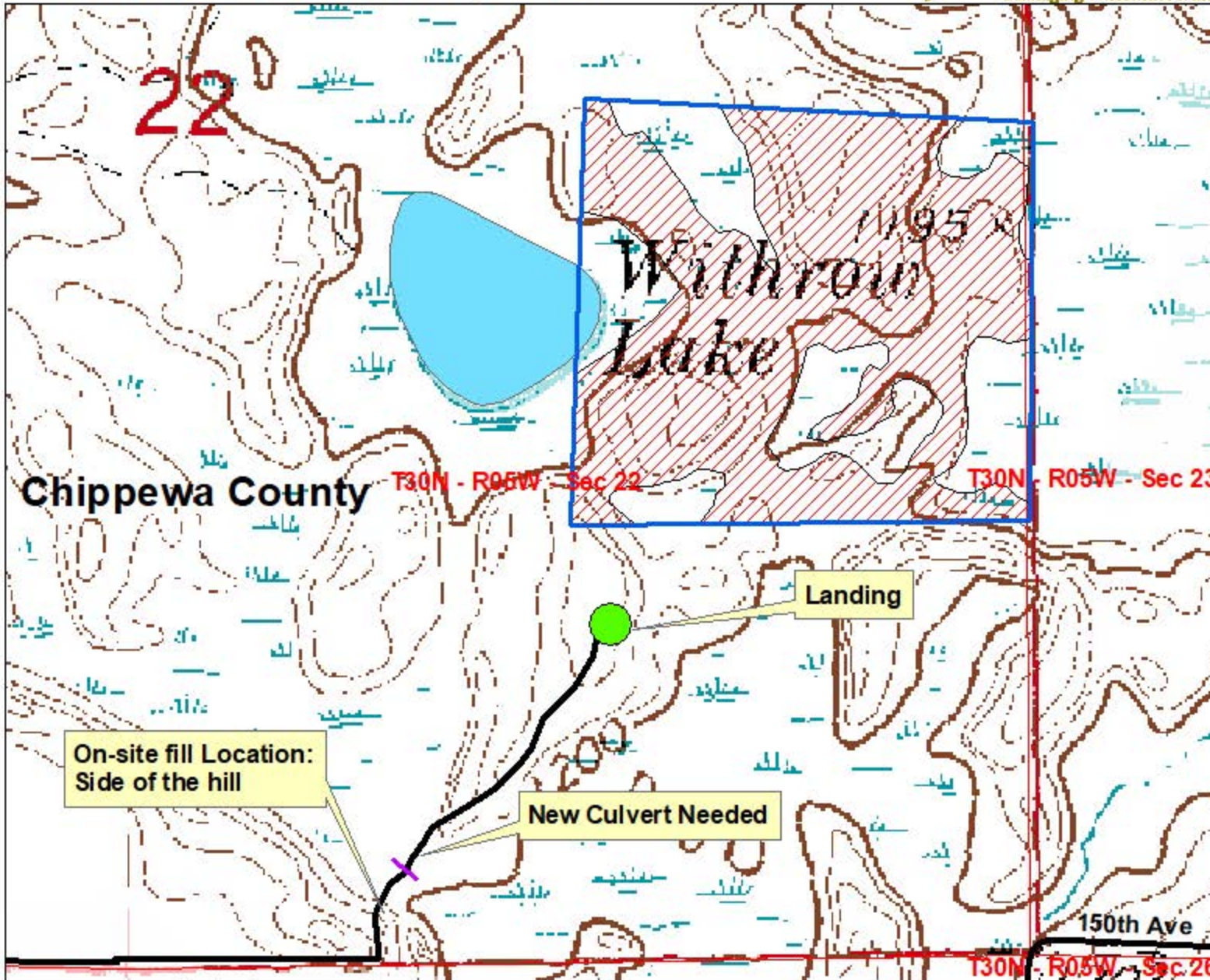
