ITEM 1. CALL TO ORDER

Board Chair Godlewski called the meeting to order at 1:31 p.m.

ITEM 2. APPROVE MINUTES

MOTION: Commissioner Kaul moved to approve the minutes; Commissioner Leiber seconded the motion.

DISCUSSION: None.

VOTE: The motion passed 3-0.

ITEM 3. APPROVE LOANS

MOTION: Board Chair Godlewski moved to approve the loans; Commissioner Leiber seconded the motion.

DISCUSSION: Mr. Sneider shared that Loan #1 is to the City of Waukesha. The city is demolishing a building within their tax incremental district 17, which includes some asbestos abatement. Loan #2 is another broadband project for the Village of Sister Bay. Loan #3 is to finance an improvement to the sewer system for the Village of Turtle Lake. Loan #4 is a bread and butter loan for roadwork to the Town of Wilson in Sheboygan County. Loan #5 is to the Village of Ellsworth. The village is demolishing an old school building and is seeking to sell that improved lot to a developer for a multifamily project. Loan #6 to the Village of Slinger is for a land purchase. The land is to be used for a new police facility and currently includes a museum. The village wants to buy the land under the museum which is currently leased to the museum by a private party. The land purchase is going to include that land for the museum and the building of a new police facility on that land.

VOTE: The motion passed 3-0.

The Board of Commissioners of Public Lands (BCPL) unanimously approved \$7,775,000.00 in State Trust Fund Loans to support 6 community projects in Wisconsin.
