<u>SALE OBJECTIVES</u>: The harvest objective is to remove the overstory as the second cut of a two-cut shelterwood to convert the stand to red oak. Be careful to run over as little regeneration as possible during all logging operations. Almost all of the logs are small and medium sized logs between 12 and 18 inches in DBH. The pulpwood also has a significant fraction of bolts. Quality in the red maple is very good with an estimate of 8-10% veneer.










Scale 1:120,000 Township: Lac Du Flambeau Cutting Area : 50 Acres
