- 1) Cut all aspen, red and sugar maple, and white birch with one or more sticks.
- 2) Cut all trees marked in orange paint.
- 3) Do not cut any trees marked in teal paint, they are leave trees.
- 4) Do not cut any trees marked in red paint, they are line trees.
- 5) Cutting boundaries are marked in red or blue paint lines.
- 6) Logging will be allowed from July 15 to October 15th in dry conditions or in the winter from Dec. 1 to March 15th.

<u>SALE OBJECTIVES:</u> The harvest objective is thin out the oak and white pine stands and to regenerate the mixed red maple/aspen stands back to an even-aged aspen/red maple stand. Some trees were marked in teal paint to retain for wildlife habitat and to prevent epicormic sprouting on high-quality red oak crop trees.

<u>Access</u> - Direct town road access from the Oscar Jenny Lake road to the main Woodboro Wildlife Area rd.. High quality, Unrutted, woods roads bisect the property ensuring very short skidding distances.

OTHER SALE REQUIREMENTS AND CONDITIONS:






