**SALE OBJECTIVES:** The harvest objective is to release excellent regeneration in gaps started in a shelterwood cut about 10 years ago. The regeneration is about ½ to 1 inch in diameter and can withstand logging without much breakage. Marking removed suppressed, poor- quality trees, large pulpwood, prime veneer and good quality sawlogs between 16-20 inches DBH. Most of the sugar maple logs are grade 2 with significant amounts of grade 1 and some grade 3. All species have some veneer with the most in basswood and red maple. Log volume estimates are based upon random lengths.

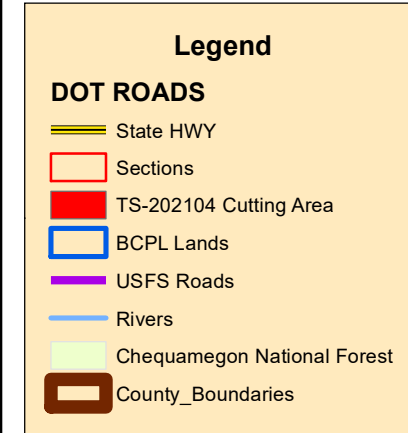
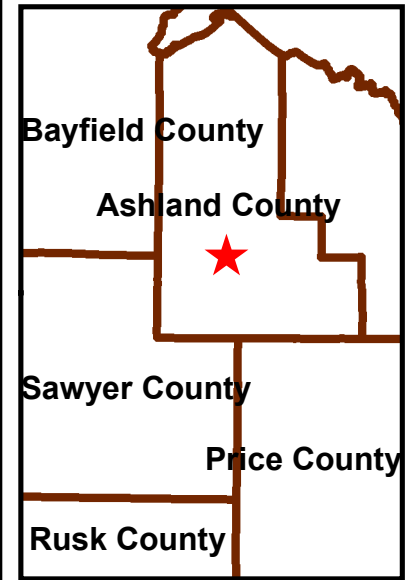
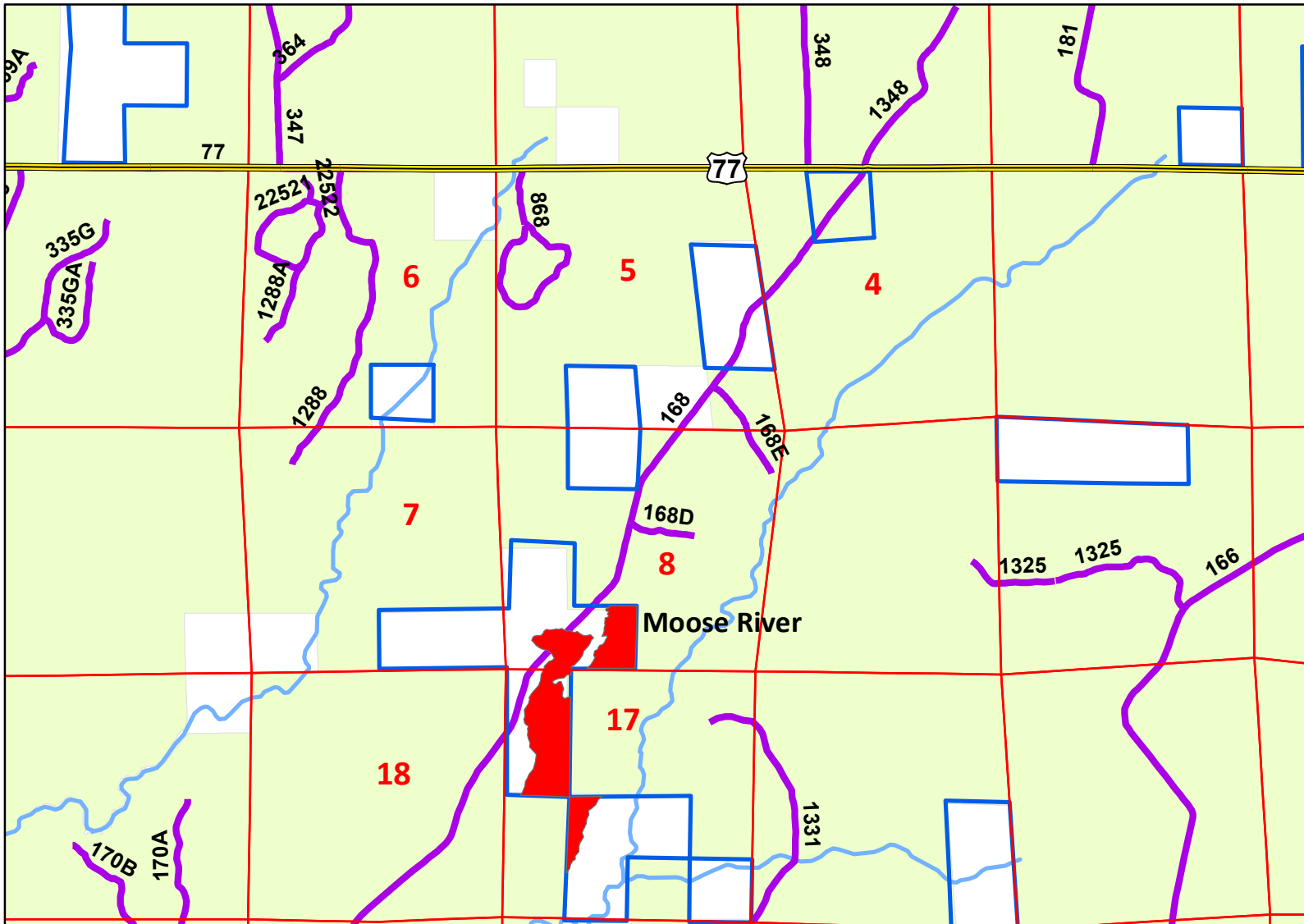
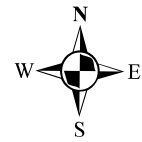
**Access & Terrain-** Direct town road access from USFS Rd. #168. Unrutted woods roads bisect the property ensuring short skidding distances. Terrain is mostly flat or rolling hills with a few areas of wet, rocky soils. Due to the abundant sapling regeneration, visibility in the summer would be nearly impossible requiring a winter cut. Volume per acre is low but the volume per tree is very high. Logging efficiency should be very good.

**OTHER SALE REQUIREMENTS AND CONDITIONS:**

- The BCPL can restrict the type of equipment used on the job if conditions or damage warrant.
- Weight/volume conversion factors are listed in the general timber sales conditions and are identical to those listed as in the Wisconsin DNR Timber Sale Handbook. For hardwood pulp, the tons to cord ratio is 2.5
- BMP's (see Field Manual PUB-FR-093-2010) are mandatory for this sale.
- Notify the BCPL (715-277-3366) before you start the job.

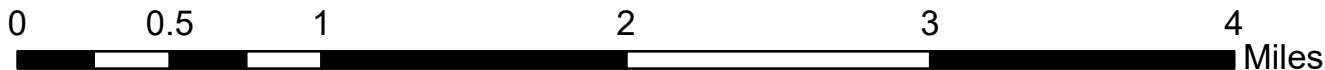

## Locator Map



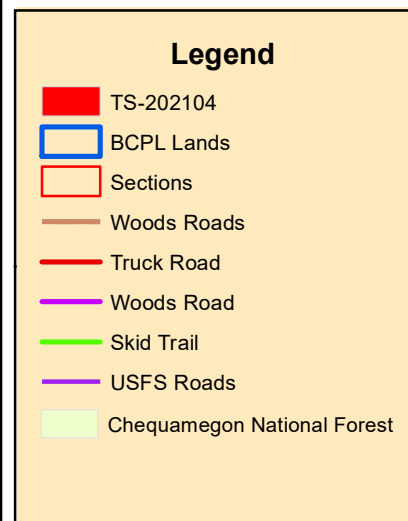
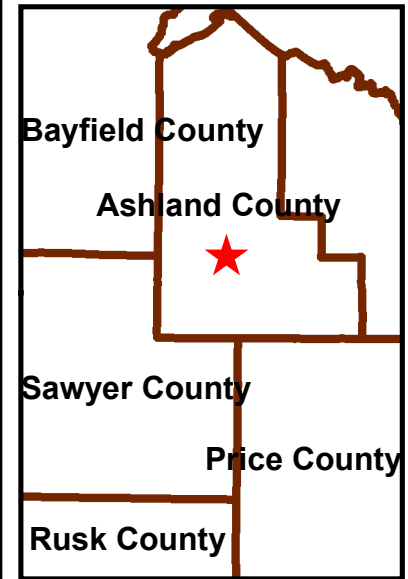
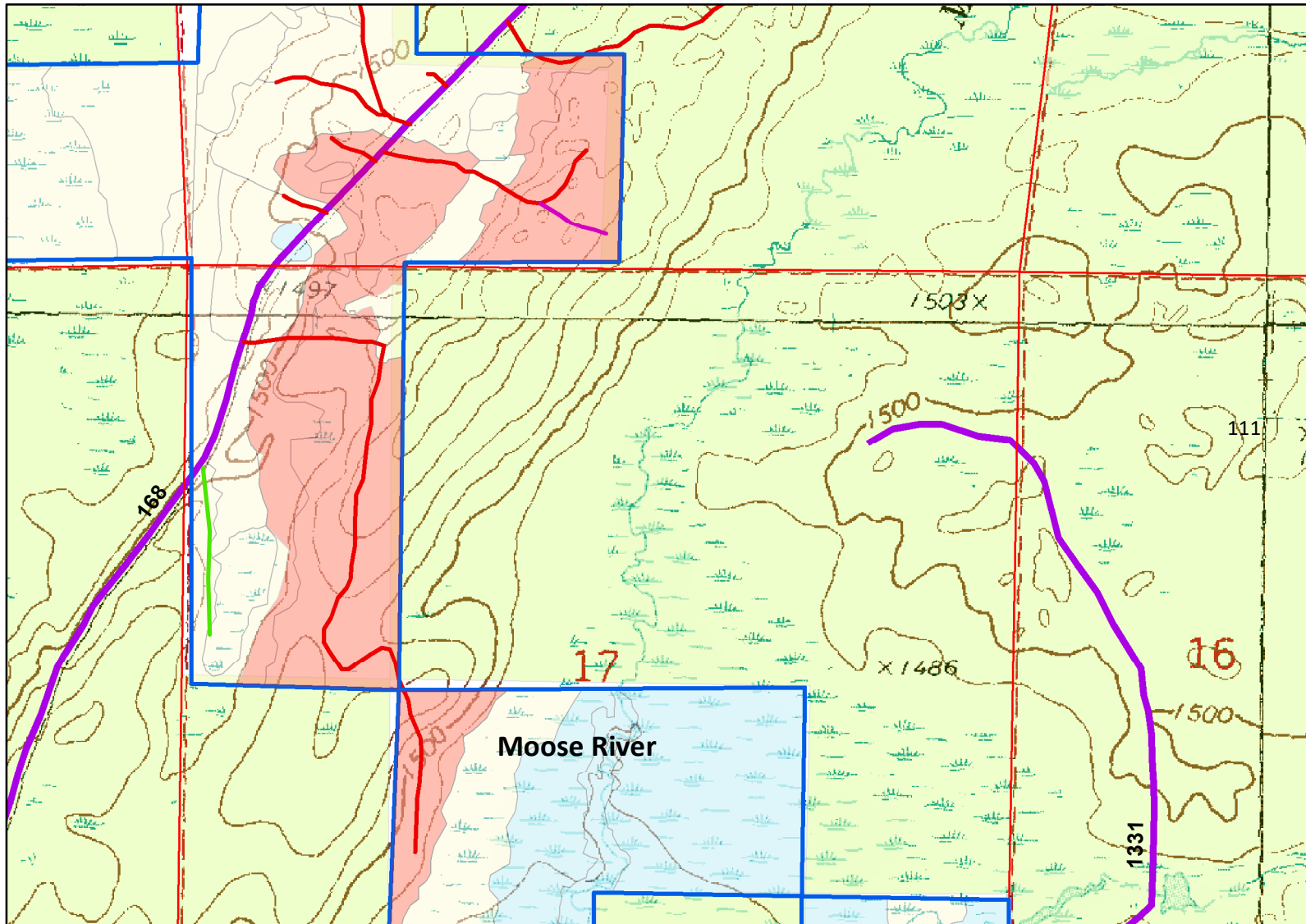
