ITEM 4. LAND BANK SALES – Sale of Trust Lands to Sawyer County

Board Chair La Follette explained that the agency had been granted the authority to sell Trust Lands and then use those funds to purchase productive timber lands. He added that this authority would allow the agency to manage the Trust Lands more efficiently. He thanked the staff for the detailed documents that they had prepared.

NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves the sale of all or any portion of the Property to Sawyer County at the appraised values determined by Solum & Associates whose total appraised value of the Property is One Million Six Hundred Seventy-Six Thousand Seven Hundred Ninety-Five Dollars (\$1,676,795). Such sale(s) shall be conducted in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. Any transactions conducted under this approval shall be closed no later than December 31, 2007. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction(s).

MOTION: Commissioner Sass moved to approve the resolution; Commissioner Van Hollen seconded the motion. The motion passed 3-0.

ITEM 5. EXECUTIVE SECRETARY'S REPORT

Executive Secretary Nelson asked for confirmation from the new commissioners to continue holding the board meetings on the first and third Tuesday of each month at 2:00 p.m. Commissioner Van Hollen asked if the meetings were always held via teleconference. Executive Secretary Nelson replied that the meetings to approve loans were but on occasion the Board will meet in person to discuss and approve land transactions when needed. Commissioner Van Hollen indicated that the routine meetings were acceptable. Board Chair La Follette suggested that the Board meet in person in the near future.
