MOTION: Commissioner Van Hollen moved to approve the loans; Commissioner Sass seconded the motion. The motion passed, 3-0.

ITEM 4. PROPOSED LAND BANK PURCHASE – POTLATCH / MOOSE LAKE

Commissioner Van Hollen asked if an analysis had been performed to justify the purchase of the land and its return in terms of timber revenue compared to lending the funds via the State Trust Fund Loan Program. Executive Secretary Nelson replied that a formal economic analysis had not been done. She was confident that given the property's \$525 per acre price and its high value timber, an analysis would have been comparable. Commissioner Van Hollen said that if the objective was to increase earnings for the Common School Fund, then an analysis would have to be completed. If it was to reduce non-productive timber land and acquire productive timber lands, then this purchase met the criteria. Executive Secretary Nelson said that procedures and criteria were developed when the Land Bank Authority was granted to the agency. The overall goal is to increase timber productivity in the Board's timber portfolio regardless of the fund. She said that the Land Bank legislation requires that the land bank proceeds be invested in other lands.

MOTION: Commissioner Van Hollen moved to approve the purchase of the Potlatch property; Commissioner Sass seconded the motion. The motion passed, 3-0.

NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands authorizes the purchase of the Property at a price of up to One Million, Five Hundred One Thousand One Hundred Ten Dollars (\$1,501,110) in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such purchase transaction.

AGENDA ITEM 4 LOAN LIMIT EXCEPTION – TOWN OF WINDSOR

The town of Windsor has requested an exception to the loan limit, which is currently set at \$5 million for all loans to any customer in a calendar year. This is Windsor's first request for a State Trust Fund Loan in 2009.

The town of Windsor's current loan limit request in the amount of \$5,582,895 is for the purpose of refinancing an existing note used to finance economic development in an industrial park. The proposed loan to Windsor would be for a term of 5 years and carry an interest rate of 3.50%.

BCPL has approximately \$90 million in unencumbered funds available to lend at this point in time. While the agency received unprecedented demand for loans over the last six months, BCPL staff feels that we have adequate funds to honor this request without impairing other communities' ability to borrow through the program. Additionally, unencumbered funds in the State Investment Fund are earning less than 1%. Since the requested loan would carry an interest rate of 3.50%, this loan request would provide more trust fund income than if the money were left in the State Investment Fund. Therefore, we believe that this loan will offer the Board a good opportunity to make a prudent investment with a good rate of return and help a Wisconsin community in its economic development efforts during this difficult economic time.

BCPL staff recommends that the Board of Commissioners of Public Lands grant the town of Windsor's request for an exception to the loan limit in an amount sufficient to allow Windsor to apply for a \$5,582,895 loan at this time.
