Executive Secretary Nelson reported that the balance of funds to lend was \$60 million and staff was anticipating an increase in demand for Trust Fund Loans due to a provision in the federal budget (Build America) that would allow municipalities to receive subsidy on interest rate payments at no cost to BCPL. Staff may in the near future recommend that requests for exceptions to the \$5 million loan limit be suspended.
