4A. CREX MEADOWS (S0920) - NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves the sale of the Crex Meadows Property to the Wisconsin Department of Natural Resources at the price of Eighty-five Thousand Dollars (\$85,000) in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction.

4B. MAPLE RIDGE ROAD (S0919) - NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves the sale of the Maple Ridge Road Property to the Wisconsin Department of Natural Resources at the price of One Hundred and Twenty Thousand Dollars (\$120,000) in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. AGENDA ITEM 4 RATIFICATION OF LOAN LIMIT CHANGE

In consultation between the Board Chairman and the Executive Secretary, the annual loan limit for any State Trust Fund Loan Program borrower in a calendar year was lowered from \$5 million to \$2.5 million.

The dollar volume of loan applications has been rising steadily over the past few months. Much of this increase is attributed to the implementation of the federal Build America Bond program, which provides a federal subsidy on municipal borrowing. We received more than \$25 million in loan applications in May and almost \$35 million in June. These totals included a number of loan applications for \$5 million each. As a result, the amount of unencumbered funds available for lending under the State Trust Fund Loan Program has decreased significantly and is now less than \$50 million. Lowering the annual customer borrowing limit to \$2.5 million would keep the State Trust Fund Loan Program a viable option for medium size projects while also keeping funds available for the vast majority of our smaller borrowers that have limited borrowing options.

We ask for board approval and ratification of the interim action.

NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves and ratifies the actions of the Executive Secretary and Board Chairman in lowering the annual loan limit for any customer in a calendar year from \$5 million to \$2.5 million. The Executive Secretary is authorized and directed to take any actions reasonably necessary to implement this decision.
