AGENDA ITEM 4 PROPOSED LOAN LIMIT INCREASE

BCPL staff requests that the Board approve raising the annual loan limit for any State Trust Fund Loan Program borrower in a calendar year from \$1 million to \$5 million.

Since January 1, 2010, we have received a substantial amount of loan "prepayments" that increased our Trust Fund cash balance. In addition, monthly loan demand has decreased significantly since October of last year, averaging only \$4.6 million over the last three months, in comparison to \$24 million per month for the previous six months. We believe our lower (\$1 million) annual loan limit reduced demand for the State Trust Fund Loan program, as we anticipated.

As of today, we have \$35.2 million available to lend and we expect to have almost \$75 million available after annual loan payments are received in March.

Our agency did an excellent job last year in managing its available cash position over the second half of 2009 as our available fund balance decreased. It's important to act timely with respect to our future anticipated increases in available funds. As our cash position grows, it becomes more important to put that money back to work earning a higher rate of return. The reason for this is that our average loan rate is 5.06% while our cash is earning a maximum return of .5%. The more money we loan out, the better our Trust Fund earnings will be.

The loan limit increase should greatly increase our volume both in terms of number of applications and loan dollar amount. This will in turn have a positive long term impact on earnings. When BCPL reduced its loan limit to \$1 million last year, we stopped financing many of the larger Build America Bond-designated projects; many of which were long term loans earning a high rate of return. Since we now have more funds available to lend again, with a loan limit increase, we will once again be able to finance many of these larger projects.

For the above reasons, BCPL staff asks for board approval for raising the annual loan limit for any customer in a calendar year from \$1 million to \$5 million.

NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves raising the annual loan limit for any customer in a calendar year from \$1 million to \$5 million. The Executive Secretary is authorized and directed to take any actions reasonably necessary to implement this decision.
