**MOTION:** Commissioner Sass moved to approve the loans; Commissioner Van Hollen seconded the motion. The motion passed, 3-0.

#### ITEM 4. SUBMERGED LANDS LEASE – FRASER SHIPYARDS INC.

Board Chair La Follette said that Fraser Shipyards currently has a submerged lands lease with the Board. They would like to expand their harbor facilities to construct one continuous dock, which will provide easy berthing of ships and improve access to ships for loading and maintenance. These improvements would require a new lease with the Board. Fraser Shipyards wishes to retain the existing lease but amend it by deleting the leased area that will be covered under the new lease. They also propose reducing the annual lease obligations on the existing lease on a pro rata basis since they would otherwise be paying twice for the same area. The new lease would have a beginning lease rate slightly more than \$4,000 per year.

MOTION: Commissioner Van Hollen moved to authorize the lease; Commissioner Sass seconded the motion.

Commissioner Van Hollen asked how the lease payment would be adjusted over the life of the lease. Executive Secretary Nelson replied that she and the Deputy Secretary had discussed a five-year adjustment of the lease rate.

**VOTE:** The motion passed, 3-0.

**NOW, THEREFORE BE IT RESOLVED**, that the Board of Commissioners of Public Lands authorizes a new fifty-year Submerged Lands Lease with Fraser Shipyards Inc. in accordance with Section 24.39 of the Wisconsin Statutes with a beginning rental rate of Four Thousand One Hundred Twelve Dollars and Fifty Cents (\$4,112.50) per year on such other terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction.

**BE IT FURTHER RESOLVED,** that the existing Submerged Lands Lease with Fraser be amended to exclude any areas covered under the new proposed Submerged Lands Lease and the annual rental obligations of Fraser under the existing lease shall be reduced pro rata in accordance with the change in leased area.
