ITEM 4. PROPOSED LAND EXCHANGE WITH NICKOLAS SOMERS (E0903)

MOTION: Commissioner Schuller moved to approve the land exchange; Commissioner Van Hollen seconded the motion. The motion passed 2-0.

NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves the exchange of Parcel A for Parcel B with Nickolas Somers in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction.

ITEM 5. PROPOSED ONEIDA COUNTY EASEMENT PURCHASE

MOTION: Commissioner Van Hollen moved to approve the easement purchase; Commissioner Schuller seconded the motion. The motion passed 2-0.

NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves the purchase of the access easement from the Robertson's for the sum of \$4,000 in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction.

ITEM 6. EXECUTIVE SECRETARY'S REPORT

Deputy Secretary German reported that BCPL staff had discussions with the WI Economic Development Corporation and other state agencies regarding the aftermath of the thunderstorm that knocked down trees on 130,000 acres of land in northwestern Wisconsin. During those discussions, Mr. German explained how the State Trust Fund Loan Program could be used by counties or other local municipalities to help finance logging and timber storage activities. Commissioner Van Hollen asked if BCPL has any Trust Land in the vicinity of the storm that could be used for storing cut timber. Mr. German replied that he did not know the answer to that question but he would investigate.

Commissioner Schuller commended Deputy Secretary German on his assistance helping legislators draft the proposed revenue obligation loan bill, which was referred to the Committee on Urban and Local Affairs.

MOTION: Commissioner Van Hollen moved to adjourn the meeting; Commissioner Schuller seconded the motion. The motion passed 2-0.
