**MOTION:** Commissioner Van Hollen moved to approve the proposed land bank sales and land bank purchase; Commissioner Schuller seconded the motion. The motion passed 3-0.

**4A. NOW, THEREFORE BE IT RESOLVED**, that the Board of Commissioners of Public Lands approves the sale of the Property to the Forest County Potawatomi Community at the price of Four Hundred Forty Eight Thousand Dollars (\$448,000) in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction.

**4B.** NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves the sale of the Bluff Road Property to Jackson County at the price of Eighty Thousand Dollars (\$80,000) in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction.

**5.** NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves the purchase of the Cavour Property from the Forest County Potawatomi Community at the price of Fifty-Two Thousand Dollars (\$52,000) in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction.

# ITEM 6. PROPOSED MEMORANDUM OF UNDERSTANDING WITH FOREST COUNTY POTAWATOMI COMMUNITY

**MOTION:** Commissioner Van Hollen moved to approve the MOU; Commissioner Schuller seconded the motion.

**DISCUSSION:** Executive Secretary Nelson explained that the MOU formalizes an informal working relationship that has been established over the years between the Tribe and the BCPL. The agreement does not bind either party to any particular future action or agreement but rather establishes a framework for cooperation and information sharing. The MOU was reviewed by legal counsel at the Department of Justice.

**NOW, THEREFORE BE IT RESOLVED**, that the Board of Commissioners of Public Lands authorizes and directs the Executive Secretary to execute an MOU with the Forest County Potawatomi Community in substantially the form attached hereto as Exhibit A and take whatever actions are reasonably necessary to implement the MOU.

**VOTE:** The motion passed 3-0.

### ITEM 7. EXECUTIVE SECRETARY'S REPORT

Executive Secretary Nelson reported that Jeff Niese, BCPL Senior Forester, will be retiring on September 14. A recruitment was conducted in August/September and an offer was made and accepted by Keb Guralski. Mr. Guralski is a 2006 forest management graduate of UW-Stevens Point and has been working for the Colorado State Forest Service. He brings a wealth of knowledge and experience to the agency.
