ITEM 4. PROPOSED LAND BANK SALE TOWN OF WASCOTT PROPERTY (S1205)

MOTION: Commissioner Van Hollen moved to approve the land bank sale; Commissioner Schuller seconded the motion. The motion passed 3-0.

NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands approves the sale of the Town of Wascott Property to Douglas County at the price of Sixty-five Thousand Dollars (\$65,000) in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction.

ITEM 5. EXECUTIVE SECRETARY'S REPORT

Executive Secretary Nelson commended staff for getting access to the Douglas County parcel which increased the sale value.

She also noted that in the upcoming budget request, DOA recently expressed a willingness to convert the agency's land records LTE position to an FTE with a nominal change in total appropriation request. BCPL's budget request would still be at just a cost to continue level but would be structured to now address a long standing statutory responsibility of the agency.
