### ITEM 4. PROPOSED LAND BANK SALE – GRUB HOE LAKE (S1108)

**MOTION:** Commissioner Van Hollen moved to approve the land sale; Commissioner Schuller seconded the motion. The motion passed 3-0.

**NOW, THEREFORE BE IT RESOLVED**, that the Board of Commissioners of Public Lands approves the sale of the Grub Hoe Property to the U.S. Forest Service at the price of Three Hundred Five Thousand Dollars (\$305,000) in accordance with Chapter 24 of the Wisconsin Statutes on such terms and conditions as the Executive Secretary determines to be reasonable and necessary. The Executive Secretary is authorized and directed to execute any documents reasonably necessary to complete such transaction.

# ITEM 5. PENDING LEGISLATION ON UNCLAIMED PROPERTY AND THE COMMON SCHOOL FUND

Board Chair La Follette asked for discussion on the topic.

**MOTION:** Commissioner Van Hollen moved to table the discussion.

Concern was expressed about the diversion of unclaimed property revenue and the potential impact on the Common School Fund.

**SECONDED:** Commissioner Schuller seconded the motion.

Board Chair La Follette expressed his desire for staff to monitor the proposed legislation and inform them of any activity.

**VOTE:** The motion passed 3-0.

Board Chair La Follette inquired about the status of an op-ed piece drafted by Executive Secretary Nelson, which details the history of the Board, its duties and the programs it oversees. Commissioner Van Hollen was unable to review the document within the original deadline but will do so in the near future.

#### ITEM 6. EXECUTIVE SECRETARY'S REPORT

Executive Secretary Nelson reported that she continues to do outreach activities with policymakers, timber producers and municipal officials and, as a result, will be traveling quite a bit in the coming weeks.
