#### ITEM 4. EXECUTIVE SECRETARY'S REPORT

She reported that she and staff have been working over the last year to convene a group of timber management stakeholders, including government land managers, private timber company representatives, and conservation organizations, to conduct timberland management research. The group has been working with the UW-Stevens Point and a meeting will be held the end of August to examine the outcome of the research.

She and staff will be meeting with the State of WI Investment Board's new Executive Director, Michael Williamson, to discuss investment opportunities that will benefit the School Trust Funds.

Finally, the agency is in the very early stages of another land trade with the US Forest Service. This trade will help to consolidate the agency's School Trust Lands and increase the timber revenue potential on those lands.
