ITEM 1. CALL TO ORDER

Board Chair Schimel called the meeting to order at 2:12 p.m.

ITEM 2. APPROVE MINUTES – JANUARY 19, 2016

MOTION: Commissioner La Follette moved to approve the minutes; Commissioner Adamczyk seconded the motion.

DISCUSSION: None.

VOTE: The motion passed 3-0.

ITEM 3. APPROVE LOANS

Board Chair Schimel asked if the loans had been reviewed for public purpose. Executive Secretary Barry confirmed they had.

MOTION: Commissioner La Follette moved to approve the loans; Board Chair Schimel seconded the motion.

DISCUSSION: None.

VOTE: The motion passed 2-1. Commissioner La Follette and Board Chair Schimel voted aye; Commissioner Adamczyk voted no.

ITEM 4. REQUEST TO RATIFY ADJUSTMENTS TO LOAN PROGRAM INTEREST RATES

Executive Secretary Barry said that Treasury interest rates had dropped substantially in the last month and staff had recommended that the interest rates for State Trust Fund Loans also be reduced. (Board policy gives the Executive Secretary in consultation with the Board Chair the authority to approve interest rate adjustments between meetings and then present those adjustments for ratification by the full Board.)

MOTION: Commissioner La Follette moved to ratify the recent State Trust Fund Loan interest rate adjustments; Board Chair Schimel seconded the motion.

DISCUSSION: Board Chair Schimel confirmed that he had previously approved the interest rate adjustments with the Executive Secretary in accordance with the Board's policy.

VOTE: The motion passed 3-0.

NOW, THEREFORE BE IT RESOLVED, that the Board of Commissioners of Public Lands ratifies the changes in BCPL State Trust Fund Loan Program, with annual interest rates to be set at 2.50% for 1-2 year loans, 2.50% for 3-5 year loans, 3.00% for 6-10 year loans, and 3.50% for 11-20 year loans.

Executive Secretary Barry reported that he and Deputy Secretary German had met with members of the Legislature to discuss BCPL's work.
