### CUTTING REQUIREMENTS:

- 1) Do not cut any oak, pine or hemlock.
- 2) Do not cut any elm >16" and leave scattered punky aspen >20".
- 3) Cut all other species >5" DBH with one or more sticks.
- 4) Summer logging if logger fixes access road to acceptable summer hauling standards, otherwise winter only logging Dec 1 - April 1.

**SALE OBJECTIVES:** 1 ) Clearcut to regenerate a fully stocked aspen stand with a mixed hardwood component.

**ACCESS & TERRAIN:** Good gravel road access via the Browns Rd from Hwy 8. One half mile of woods road will need to be fixed to summer hauling standards if summer logging is desired. Terrain is flat and can support summer logging under dry conditions. If road work is not completed by the logger, then winter only logging Dec 1 – April 1 due to poor woods roads.

### OTHER SALE REQUIREMENTS AND CONDITIONS:

- The BCPL can restrict the type of equipment used on the job if conditions or damage warrant.
- Logging operations may be suspended if excessive rutting is occurring.
- BMP's (see Field Manual PUB-FR-093-2010) are mandatory for this sale.

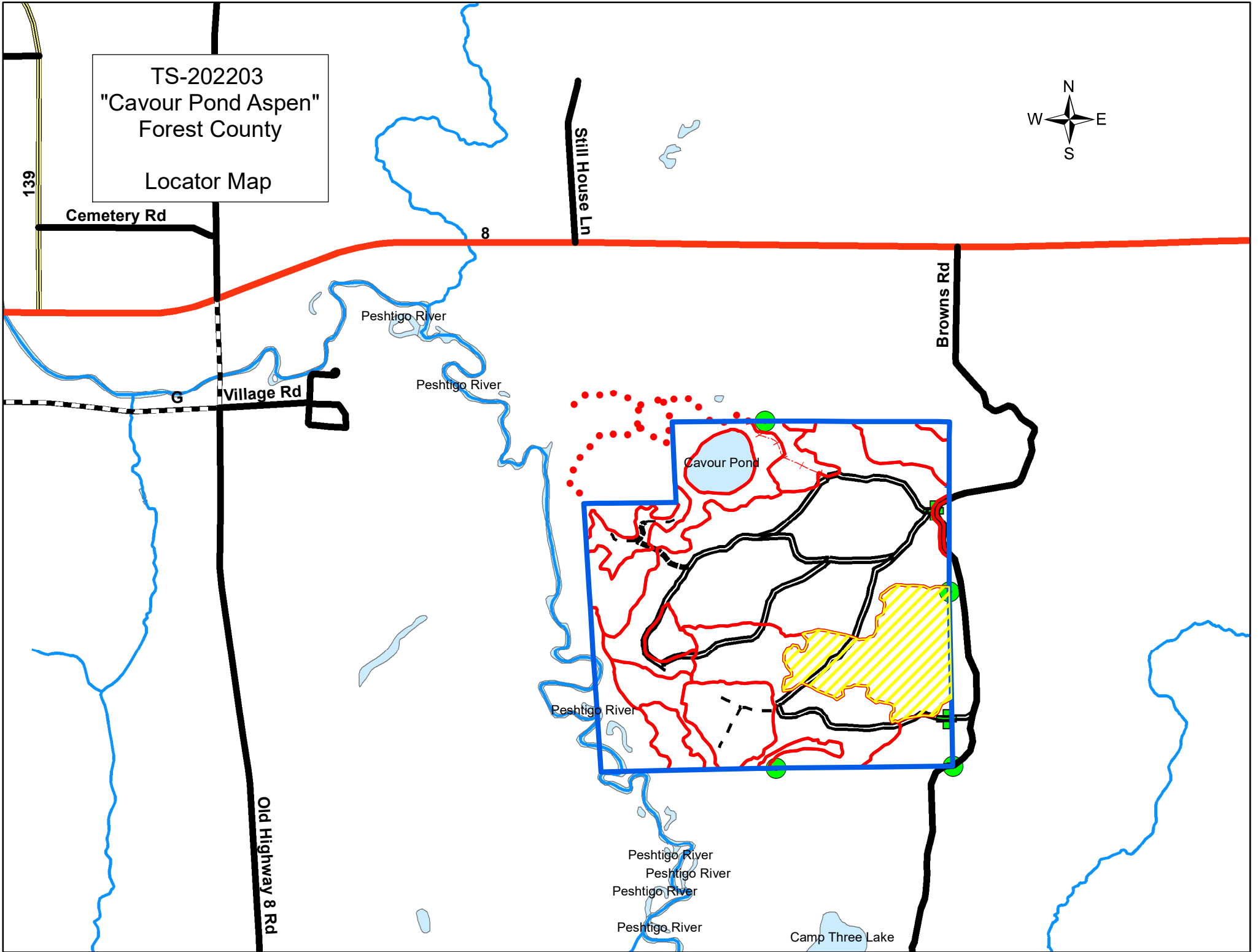
